The emphasis is nonpartisan education for leadership. This is an opportunity to share information to these leaders and show our collaboration. It's important that this is shown prior to legislative session as the legislators will be very busy once the session starts. We have the mailing list, location arranged, light food, and timeframe is being solidified. We have another meeting to continue planning next week.</li> <li>Kendall: Dawn Tolan helping with location and West Ada partnership, Earl is working on food donations. We are looking at wanting to have the logos of all the partners represented so that the legislators are aware of everyone that are in support of this education effort. Kendall reached out to Representative Moon to talk with the coalition. Rep. Moon was the sponsor for HB577 last session. Moon has interest in talking with the coalition and has us penciled in and is willing to be a guest speaker to our group at Novembers MADC meeting. We can always learn a lot from both sides of this debate, it's a great opportunity. Ternel would like to request the data that she has regarding the effectiveness of cbd oil. Ternel would also like to know what controls would be in place to ensure safe regulation. Kendall would recommend that we read House Bill 577 again prior to her coming and speaking. Sgt. Frasier discussed the fact that Moon is calling upon medical professionals to be that control, however they legally can't because it's illegal federally. There is no agency in Idaho that is able to regulate these types of products, and the cost of that is obscene to make that happen. Sgt Gonzales spoke to the fact that ID is being challenged with this issue. Now that Canada has legalized it, ID will continue to receive pressure to legalize marijuana.</li> </ul> |
