- Deputy Chief Butterfield provided update on new Water Tender Apparatus with a due date of late-January 2024 and in-service date of early February 2024. Chief Blume and Deputy Chief Butterfield will travel to Florida for final inspection in January. Hughes Fire will deliver the unit to Meridian (driving). City of Boise still has interest in purchasing the old water tender apparatus.
- Station #8 Open house went well. State-of-the-art Fire, police, and EMS facility.
- No other old business discussed

#### New Business:

- MRFPD 2024 monthly meeting dates presented mirroring 2023. Meeting dates approved.
- Chief Blume provided that the MFD monthly operational update.
  - First item: SAFER Grant amended and accepted modified from 24 personnel to 18 personnel during three year timeframe.
  - Opticom System: Pre-empting predictive system. Goal is to reduce response times by 15-20% cloud based and predictive. Software can alter stop lights and allows fire to not have to stop or slow thus lowering active response time. Software will cover the intersections throughout the city of Meridian. Upgrade to Cradlepoint System on fire vehicles.
  - Darkhorse predictive analytic tool/software. City of Meridian approved purchase. MFD awaiting next steps. Next update January 2024. Software product allows for customization to meet specific municipality needs.
  - Meridian Fire leadership is meeting to discuss their ten-year strategic operational plan. Discussion items include updates/ upgrades and staffing models for all stations.
  - Accreditation for Meridian Fire Department led by Deputy Chief Butterfield. Accreditation team was on site and gave thorough
